MYLAN FAIR FUND NOTICE

Dear Investor:

This letter is to inform you of the existence of the Mylan N.V. Fair Fund (the “MFF”), established by the Court with the proceeds of a U.S. Securities and Exchange Commission (“SEC”) enforcement action against Mylan N.V. (“Mylan”). The MFF will compensate investors who purchased Mylan common stock (“MYL”) between March 2, 2015 and September 1, 2016, a period in which the market for the company’s shares was affected by Mylan’s alleged misrepresentations relating to the misclassification of the EpiPen. If you acquired MYL during this time period, you may be eligible to receive compensation in accordance with the provisions of MFF’s Distribution Plan approved by the Court.

On the reverse side of this letter, a formal notice provides additional information regarding the MFF. Please review the notice in detail and follow the instructions regarding how to apply for a recovery.

Fair Fund to Compensate Certain Investors in Mylan N.V. Common Stock

NOTICE: *The Mylan N.V. ("Mylan") Fair Fund ("MFF") was established by the United States Securities and Exchange Commission ("SEC") to distribute the \$30 million in civil money penalties paid by Mylan to settle the SEC's charges of alleged accounting and disclosure failures relating to a Department of Justice probe into whether Mylan overcharged Medicaid by hundreds of millions of dollars for EpiPen. The MFF is intended to compensate investors who purchased shares of Mylan common stock ("MYL") through a U.S. securities exchange between March 2, 2015, and September 1, 2016. The compensation program is governed by a Plan of Distribution ("Plan") approved by the Court on August 17, 2021. Who is Eligible to Participate in the Fair Fund?

Any person or entity that purchased MYL on a U.S. stock exchange during the period from March 2, 2015 through September 1, 2016, may be eligible for compensation from the MFF subject to certain other eligibility limitations described in the Plan.

Eligible Security

Mylan Common Stock- (MYL) CUSIP: N59465109

Determination of Eligible Losses

The amount of compensation shall be determined by reference to the plan of allocation included in the Plan and will vary based on the exact dates of transactions in MYL during the relevant period, the number of shares of MYL purchased and/or sold, and the total dollar value of eligible claims submitted to the MFF. A person's eligible loss amount may be reduced by the amount of any compensation for the loss that resulted from the conduct described in the complaint in this case that was received from another source (e.g., class action settlement). If the sum of all approved claims exceeds the monies available for distribution, payments will be made on a *pro rata* basis, determined by the ratio of each approved claim to the aggregate amount of all approved claims. Consistent with the purpose of Section 21(d)(4) of the Securities and Exchange Act of 1934, no funds distributed from the MFF may be used for payment of attorneys' fees or expenses.

How to Apply?

In order to be eligible for a recovery, you must submit a completed claim form and supporting documentation on or before the claims deadline. **The simplest and fastest way to participate is to file a claim online through the MFF website: mylanfairfund.com.** If for any reason you are not able to utilize the online filing, you may download and print a copy of the claim form from the website and mail the completed claim form to the MFF at the address shown below. You may also ask the Distribution Agent to mail you a claim form by calling the toll free number (800) 678-0888, or by sending an email request to: info@mylanfairfund.com

Claim Filing Deadline

Claim forms must be postmarked no later than midnight on **March 9, 2022.** If you need assistance in completing the claim form, please contact the Distribution Agent or visit mylanfairfund.com
